Burton reported it would cost approximately \$400.00 to dig a trench two feet wide and as deep as four feet in some areas. It is a natural drainage and not a fault of Construction Utilities Corp., or the City. Property owner Brabec stated he has put in \$400.00 worth of tile and hadn't solved the problem. Mayor suggested the property owners' form an L.I.D. to raise the money to correct the situation, as the City has no money for this. D. Nay said it was up to the sub-divider to assure and insure purchases against this. Mr. Brabec also reported the Utilities Construction Corp. tore up about 8' of tile when working there. Mayor suggested he ask Utilities Construction to pay for this.

Burton reported the Kilpatrick's home is using the Convalescent Center meter. Meter at the Convalescent Home still not working but Muni-Corp., salesman checked it and parts have been ordered to repair it.
