**Purpose of checklist:**

The State Environmental Policy Act (SEPA), chapter 43.21C RCW, requires all governmental agencies to consider the environmental impacts of a proposal before making decisions. An environmental impact statement (EIS) must be prepared for all proposals with probable significant adverse impacts on the quality of the environment. The purpose of this checklist is to provide information to help you and the agency identify impacts from your proposal (and to reduce or avoid impacts from the proposal, if it can be done) and to help the agency decide whether an EIS is required.

**Instructions for applicants:**

This environmental checklist asks you to describe some basic information about your proposal. Governmental agencies use this checklist to determine whether the environmental impacts of your proposal are significant, requiring preparation of an EIS. Answer the questions briefly, with the most precise information known, or give the best description you can.

You must answer each question accurately and carefully, to the best of your knowledge. Amendment A.

The Port of Friday Harbor will designate 2,000 Sq. Ft. of the main pier (amendment A map) previously occupied by garbage dumpsters. This space is to be used as temporary and seasonal event space, craft and food space, and permanent guest services facilities. Permanent Guest services would be utilized for check-in, package storage, and reuse center. These are ancillary water enjoyment uses while the pier continues to serve its primary water dependent purpose.

Additionally, the Port will designate 500 sq. ft. in the existing Fairweather Park picnic shelter to be used for temporary and seasonal event space, and craft and food sales space. These are ancillary water enjoyment uses while the park continues to serve its primary public water access purpose.
