Riding skateboard, inline skating, or skating on sidewalk within business district	FHMC 12.08.030	\$50.00
Negligent riding of skateboard or inline skating on streets, sidewalks, or publicly owned property	FHMC 12.08.040	\$50.00

Any violation of Town's traffic ordinance shall be punishable in accordance with the applicable provisions of Chapter 308-330 WAC, Parking Infractions, for which penalties are not provided for in Chapter 308-330 WAC, shall be as set forth in the town bail schedule, but shall not exceed such limits, if any, as may be established by state law or rule of the Washington State Supreme Court. In addition to such penalties as are provided for in this section, there shall be imposed a penalty of \$25.00 for failure to respond to any notice of traffic infraction relating to parking, including parking infractions defined by local ordinances of the town of Friday Harbor.
