RESOLUTION NO. 06-14

A RESOLUTION of the Board of the Friday Harbor Transportation Benefit District approving an interlocal agreement with the Association of Washington Cities Risk Management Service Agency, providing for insurance coverage, and authorizing the reimbursement of membership dues on behalf of the District to the Town of Friday Harbor.

WHEREAS, Chapter 48.62 RCW provides that local government agencies may by Interlocal Agreement, provide insurance for any purpose by certain specified methods; and

WHEREAS, The Association of Washington Cities, the sponsoring entity of the Risk Management Service Agency, would like to provide the Friday Harbor Transportation Benefit District, the opportunity to jointly self-insure or pool their primary risks; and

WHEREAS, it appears economically feasible and practical for the parties to do so; and

WHEREAS, the Town of Friday Harbor has authorized payment of membership dues pursuant to the interlocal agreement with the District;

NOW, THEREFORE BE IT RESOLVED by the Board of the Friday Harbor Transportation Benefit District as follows:

Section 1. The Interlocal Agreement with the Association of Washington Cities Risk Management Service Agency, providing for insurance coverage, is hereby approved and the Chair authorized to sign said agreement.

Section 2. The Town of Friday Harbor is hereby authorized to enroll the District in the pool and that membership dues shall be a reimbursable expense pursuant to Resolution No. 2-14.
